



Should You Redeem or Stop Investments amid Market turmoil?

At the start of Jan '03 Nifty was at around 1100 and closed at 18,100 on 31st Dec '22. This gives us a Nifty CAGR return of 14.3% over the past 21 years. However, it is evident from the graph above that the journey has not been plain sailing. Many expected and unexpected social, economic and political events have caused the markets to remain stagnant, slow down and even crash as many of us might be aware. We do not have to look too far back to remind us what happened when the pandemic struck in early 2020. Most of the time the markets made a strong comeback and continued on its upward trend.


